The SSD POLISPORTEVENTI srl is the society charged by AC MILAN to organize the Milan Junior Camp and City Camp in La Manga - Murcia -

- A. **MILAN JUNIOR CAMP.** It is organized as a typical camp: accommodation in hotel with the other participants. It is €850,00 each week: this cost includes the enrolment fee to the Camp, full board (drinks included), from seven days, transport from and to the sport field, the insurance for the selected week, Adidas kit. The price doesn't include: phone calls and extra drink-food out of the meals.
- B. **MILAN CITY CAMP.** They are the Milan Camp without accommodation in hotel. The cost is €550,00 per week and includes the enrolment fee, the lunch from six days, Adidas kit, the insurance for the selected week. The price doesn't include phone calls and any extra drinks out of the meals.

- C. **FORM OF PAYMENT:** An account of €300,00 per week must be given at the enrolment; the remaining sum must be paid within 30 days from the beginning of the Camp on the contrary the enrolment will not be valid.
- D. **BANK.** The payment could be effected to:

- E. **REVOCATION** In case of revocation the account will be returned only if the revocation is informed by registered letter at least within 30 days from the leaving.
- F. **ACQUITTANCE.** Yours truly _____
 having the paternal authority of _____,
 under my own responsibility, asserts to release SSD POLISPORTEVENTI srl and its assistants/delegates from any responsibility for damages or problems that could affect my child. Precisely Yours truly releases and dispenses the SSD POLISPORTEVENTI srl from any responsibility for both the damages caused by the usual sport activities and for any other type of damages. Moreover, yours truly asserts to release SSD POLISPORTEVENTI srl and its assistants from any responsibility for damages caused to persons and objects by the participant.
- G. **REVOCATION CLAUSE.** Should the participant take a behaviour in contrast with the civil rules and the instructions of the trainers both during the training and in hotels, he could be returned at home and the actual contract will be rescinded. The SSD POLISPORTEVENTI srl will take the sum of money and it could start a lawsuit for the damages.
- H. **LAW COURT :** for any dispute on the contract you can address only to the Law Court in Milan - ITALY-. According to the article 1341 of Italian Civil Code, everything specified in A; B; C; D; E; F; G.

REQUIRED DOCUMENTS

The following documents are required to the acceptance of the enrolment:

- **IDENTITY CARD:** (for young people under 15 years it is required birth certificate emitted by the Authority of own town / city to be used as identity card, including a photo.)
- **MEDICAL CERTIFICATE:** for young people aged from 6 to 12 years, it's necessary the certificate of healthy constitution; for young people over 12, certificate of ability to sport activities (young people already charged in any sport society have to take a copy of the Above mentioned certificate in the hands of their society).
- **Copy of SANITARY CARD:** copy of the vaccinations card, specifying the latest anti-tetanic and antidiphtheritic inoculations; give advice of any allergies.
